



# Cold Springs Wedding Venue



Alcohol may be served upon approval only. Approval must be obtained from the Owner of Cold Springs Trout Farm prior to event. Absolutely no alcohol may be brought onto the premises (including the parking lot) unless approval is given, and guidelines below are followed. If any outside alcohol is discovered, it will be immediately confiscated, and guests may be asked to leave. An \$1000 Fine may be imposed to the responsible party if the issue is not immediately resolved. No persons under the age of 21 or without a valid ID will be served. Any guest providing alcohol to a minor will be required to leave the grounds immediately.

## *Alcohol Policy*

### **Service Guidelines**

Please initial at each of the following items to show understanding and compliance with each item.

- Beer and Wine Only
- 2 Keg Max
- No Outside Alcohol Permitted (Outside Alcohol brought in by guests, not served by the bartender, will be confiscated and guests subject to dismissal)
- A Renter-hosted, no-cash bar may be provided to your guests. No cash bars allowed.
- A pre-approved, insured bar tending service must dispense all alcoholic beverages. ALL alcohol (bottled and/or poured), kegs and toasts, must be always under the supervision of a bartender. It is the Renter's responsibility to procure a bartending service for the event, and to submit the name of the bartending company and a copy of their Liquor Liability Insurance to CSTF at least 90 days prior to the event date. If liquor liability is not received, alcohol will not be allowed at the event.
- Clear Plastic Glasses only
- 3 hours Maximum for serving guests
- Alcohol Insurance Policy Required
- No Open Containers to Leave Premises
- Damage Deposit of \$1,000 (50% refundable, upon conditions of contract fulfillment.)

- The cleaning fee is non-refundable for weddings serving alcohol.
- 1 Bartender required per 75 guests

### **Cessation of Service**

Please initial at each of the following items to show understanding and compliance with each item.

Cold Springs Trout Farm reserves the right to refuse bar service to individual guests, evict Clients or their guests from the property, or to close the bar and cut power at any time during the Event. Client will not be refunded unconsumed alcohol.

Specific behaviors that will result in expulsion or bar closure include, but NOT limited to:

- Displaying intoxicated behavior, including but not limited to swerving, slurring, stumbling, fighting, destruction of property, disrespectful behavior (to other Guests, Vendors, or Cold Springs Trout Farm staff), and getting sick.
- Attempting to prevent a bartender or other representative of Cold Springs Trout Farm from refusing service to any guest.
- Allowing minor persons to consume alcohol
- Possession and/or consumption of personal supply of alcohol –this includes private vehicles located in parking areas.
- Consumption of alcohol not served by bartender

### **Bar Closure at the end of the Event:**

Please initial at each of the following items to show understanding and compliance with each item.

All bars shall close according to the following schedule:

- Last call will be announced 45 minutes before the end of the event.
- The bar will close 30 minutes before the end of the event.
- Bar must end by 9 pm.

### ***Acceptance of Terms and Conditions***

By electronically accepting the Terms and Conditions related to Cold Springs Trout Farm Alcohol Policy within 30 days after the date of the electronic mail notification, you agree to be bound by the foregoing terms and conditions and you will accept responsibility to ensure your guests follow such rules as well.
